

January 11, 2016

A special meeting of the Town Board of the Town of Greenville was held on Monday, January 11, 2016, at 7:00 pm at Pioneer Hall. Four board members were present after Councilman Bensen arrived at 7:08 pm; Councilman Stern was absent. There were 20 guests in attendance. Supervisor Macko opened the meeting with the Pledge of Allegiance.

A proposed contract between the Town of Greenville and Greenville Rescue Squad, Inc. was discussed. While the Greenville Rescue Squad has provided volunteer service to the Town since 1972, recent years have shown difficulty in obtaining enough volunteers to continue operating in this manner. A workable plan has been developed to provide paid coverage for Greenville 12 hours per day, 365 days per year. \$100,000 has been worked into the Town budget. Volunteer hours will still be used to provide care as able during the unpaid night hours. Councilman Davis noted that Town Board members were not on the GRS, Inc. Board, and expressed concern with the inability to oversee management of taxpayer money. Mr. Cliff Powell III of the Squad stated they conducted meetings openly, and would gladly provide a monthly report to the Town Board.

Mr. Bear moved, seconded by Mr. Bensen, to accept and adopt the Ambulance Contract providing for a 30 day advanced termination notice, attached.

A presentation was received from Mr. Jason Reinhard and Mr. Jason Kappel, from the Greenville Youth Soccer and Baseball Leagues. There were 262 and 225 children enrolled in these programs in 2015, respectively ~ and the numbers continue to grow. Discussion continued regarding leveling the areas in Vanderbilt Park behind the current fields to provide additional softball and soccer fields.

Mr. Bear moved, seconded by Mr. Bensen, to adopt this concept as presented.

Mr. Bear moved, seconded by Mr. Bensen, to enter executive session at 7:25 pm with members of the Library Board, to discuss the medical, financial, credit or employment history of a particular person/corp, or matters leading to said dismissal, removal, promotion, appointment, employment, discipline, demotion, or suspension.
