March 15, 2021

The regular monthly meeting of the Town Board of the Town of Greenville was held on Monday, March 15, 2021, at 7:00 pm via an audio teleconference. As required for remote meetings, in full compliance with open meeting laws throughout the COVID-19 pandemic, full audio file and text transcription are available upon request. All supporting documents referenced in these minutes are available, as well.

Identified as Present for this call: Supervisor Paul Macko, and Councilmen Bear, Bensen, Rauf, and Richards, Recording Secretary/Clerk-Collector Jackie Park, Attorney Tal Rappleyea and the following department heads: Highway Superintendent Mike Dudley, Zoning & Code Enforcement Officer Mark Overbaugh, Maintenance Supervisor Renee Hamilton, Assessor Gordon Bennett, and Planning Board Chair Donald Teator. As well, 5 guests were present for this meeting.

Mr. Bear moved to accept the Clerk's minutes of February 15, 2021, seconded by Mr. Bensen. Carried 5 aves

Monthly department reports:

Highway Department ~ Superintendent Dudley provided an oral & written report; no motions made. Building and Grounds ~ Maintenance Supervisor Hamilton provided an oral report; no motions made. Code Enforcement ~ Oral and written reports received from CEO Mark Overbaugh; no motions made. Sewer ~ Supervisor Macko noted the plant was meeting its obligations.

Water ~ An oral report was offered by Deputy Water Superintendent Hamilton with written logs per Superintendent Bear. Permission was requested to attend annual water school training;

Mr. Bear moved, seconded by Mr. Bensen, to allow Mr. Bear and Ms. Hamilton to attend the New York Rural Water class in Ghent on April 7th, expending \$50 for this education.

Carried 5 aves

Recycling ~ Supervisor Macko relayed all was well at the plant. No motions made.

Assessing ~ An oral report was offered by Assessor Bennett without motions made at this time. Planning Board ~ A summary of the last meeting was provided by Attorney Rappleyea; Planning Board Chair Donald Teator did provide a written report which is attached. No motions made. Zoning Board of Appeals ~ Supervisor Macko reviewed the minutes submitted by Clerk Nugent

from their last meeting. Beautification Committee ~ Supervisor Macko relayed the Committee would begin meeting again in

April and reported that a \$10,000 grant had been received for trail work at Vanderbilt Park. Clerk/Tax ~ Written reports provided by Clerk-Collector Park.

No reports received from the Greenville Rescue Squad or Dog Control Officer.

New business discussed at 7:15 pm:

~ Supervisor Macko addressed the recommendation of Assessor Bennett to appoint Ms. Eileen Treacy as a member of the Board of Assessment Review;

Mr. Rauf moved, seconded by Mr. Bear, to appoint Ms. Eileen Treacy to the Board of Assessment Review to fill an unexpired term ending September 30, 2022.

Carried 5 aves

~ Supervisor Macko addressed a letter of resignation received from Ms. Jean Thomas from the Zoning Board of Appeals:

Mr. Bear moved, seconded by Mr. Bensen, to accept with regret this letter of resignation, and to advertise for a vacancy on the Zoning Board of Appeals.

Carried 5 ayes

~ Requests have been made to the Town regarding a recurring Farmer's Market on a commercial property in town, as well as allowing a food cart on town-owned property. Lengthy discussion followed regarding the local Peddler's & Solicitor's Law (2002 and 2013) as well as the Yard-Sale Law (2014). While there was no issue with a Farmer's Market being held in a commercial zone per our existing law, more information is needed regarding siting a food truck at the Park, as it could impact the fundraising potential of the youth concession stand. It was determined that the Peddler's Law could be pared down/streamlined a bit, and the Yard-Sale Law could be repealed if the Board wished to do so. For follow up at the next meeting.

~ The draft pandemic policy presented last month for review was submitted to and approved by the Highway Labor Union, and may be approved by the Town Board at this time.

Mr. Bensen moved, seconded by Mr. Bear, to approve as policy the Public Employer Health Emergency Plan for the Town of Greenville, Greene County, NY; attached.

Carried 5 ayes

~ Supervisor Macko addressed the need to acquire an easement on one parcel as it relates to the sewer and water extension project. Despite ongoing attempts to contact one remaining property owner, the town has been unsuccessful in obtaining this easement.

Mr. Bensen moved, seconded by Mr. Bear, to authorize the acquisition of the lands or interests by use of Eminent Domain to implement the resolution; attached.

Roll Call requested: Supervisor Macko aye

Councilman Bear aye Councilman Bensen aye Councilman Rauf aye

Councilman Richards aye

Carried 5 ayes

~ Supervisor Macko requested a motion to hire outside Council for the land acquisition;

Mr. Rauf moved, seconded by Mr. Bensen, to utilize the Law Firm of Young/Sommer, LLC to represent the Town's interests regarding Eminent Domain. This is expected to cost between \$10,000 - \$15,000.

Carried 5 ayes

- ~ Greene County Legislator Greg Davis was present on the call at this time and offered his monthly report of activities, including grants in progress for the Boy Scouts and Food Pantry, his desire for the County to manage Covid-19 vaccine clinics instead of the State, and Facebook rumors about his voting record as it pertained to the Greene County Council on the Arts.
- ~ Delaware Engineering Engineer Alan Tavenner addressed the water and sewer extension projects. Several issues caused major delays, but soon work will be put out to bid. A change order is needed due to wetland mitigation issues for the water project;

Mr. Bensen moved, seconded by Mr. Rauf to approve Change Order #4 in the amount of \$82,767; attached.

Carried 5 ayes

~ Councilman Richards addressed the planned skateboard park, and wishes to reopen discussion about it. First, he asks we explore the cost of an insurance rider through the town policy for that coverage. He will also contact Ms. Tracy Young, who has been involved with this plan from the start.

Mr. Richards moved, seconded by Mr. Rauf, to authorize Supervisor Macko inquire on the costs of an insurance rider for this skateboard park.

Carried 5 ayes

Supervisor Macko noted he had received a request by some youth in the community to use the tennis courts for pickle ball; he feels it would be best to open up both areas for use at the same time. Neither further discussion nor motion made at this time.

~ Councilman Richards also spoke at length regarding 2 local roads once designated as 'Scenic Byways'. Upon reviewing the East Red Mill Road solar project, he discovered that two Greenville roads were previously classified as "scenic byways". This was missed by the 2018 Solar Review Committee; he

believes that is because the NYS DOT website lists these properties as being in Westchester County. A 0.45 mile section of County Route 35 (AKA East Red Mill Road) and a 0.8 mile section of Plattekill Road are both designated as such. The Environmental Law and the Highway Law also note these roads as Scenic Byways. After a review of the minutes of the Town of Greenville, two mentions were made relating to this: on 10/4/1989, there was a motion made to establish a committee to make recommendations of the possibility of having some roads designated as scenic byways. On 12/6/1989, the Committee on Scenic Roads described the roads they recommended be designated and submitted to NYS. However, the 'attached' resolution stating this was not to be found. After research by Councilman Richards, it was found that these roads were adopted by NYS in 1991. Also, a 'windshield survey' conducted by the NYS DOT in 1996 do refer to Plattekill and East Red Mill Roads.

Attorney Rappleyea noted in our adopted solar facility law there is a very specific line that says that there shall be no facilities approved in the town on any highway that has been designated as a scenic byway by the town. So, making this resolution tonight would effectively halt that East Red Mill Road application. Noted the Board isn't actually changing anything; the road has always had that designation as a scenic highway, and that this motion simply reconfirms the fact that the town asked for it previously and accepted such designation from DOT.

Mr. Richards moved, seconded by Mr. Rauf, to make a motion to adopt a resolution, accepting the findings of DOT and DEC in their designation of the scenic byways of Plattekill and East Red Mill Roads in the Town of Greenville; attached.

Carried 5 ayes

The monthly bills have been audited and approved by a quorum;

Mr. Bensen moved, seconded by Mr. Bear, to pay the following bills:

There being no further business, Mr. Bensen moved to adjourn at 8:11 pm, seconded by Mr. Richards.

2020 was a challenging year for all, and I trust the Town has navigated the changing landscape of COVID with success.



Operation and Safety Plan for "Rotary Responds 5K" on 6/5/21 in Greenville, NY (Greene County) Rotary Club of Greenville P.O. Box 591 Greenville, NY 12083 greeenvillenyrotaryclub@gmail.com

- 1. Event Map and Description (map attached.) The route for the 5k is an out-and-back route. The race begins within the Vanderbilt Town Park on Town Park Road. It then will turn left onto SR 32 (the only portion of the route which is not on a town road.). The route continues on SR 32 for 1/10th of a mile and then turns right onto Irving Road. At the intersection with Irving and Newry LANE the runners will turn left and continue onto Devan Road. At the culde-sac at the end of Devan Road the course turns around and returns to the Town Park along the same roads. We are limiting runners and walkers to 250 maximum but expect only about 100 to participate. Each intersection will be manned by Rotary volunteers with the exception of SR 32 where traffic will be directed by police, sheriff, and fire company personnel.
- 2. The event will begin at 10 a.m. at the Vanderbilt Town Park and we expect all runners and walkers to be finished by about 11:30 a.m. Set up and clean up before and after the event is expected to take about 1 hour to 90 minutes. No road closings will be required. Traffic will be paused on SR 32 to allow runners/walkers to cross. Traffic on SR 32 should not be paused for more than 10 minutes, and traffic will be directed by police and fire personnel.
- 3. Traffic control plans and the route are described above. Traffic on SR 32 will be controlled by police and fire personnel and the town road intersections will be controlled by Rotary volunteers. The traffic control devices along the route consist of stop signs only. Map of the event route is attached.
- 4. No detours will be required.
- 5. No railroad crossings exist within the town of Greenville.
- 6. Pre-event public notification will consist of listings in the local weekly newspaper, (Greenville Pioneer), on-line newspaper (Porcupine Soup), social media pages of Greenville Rotary (IG, FB). Homeowners along the route will be notified in person by Rotary volunteers. Signage will consist of 18"x24" yard signs on stakes which will be both placed and removed the day of the event. All other signage will be within the town park.
- 7. No banners will be placed either roadside or overhead.
- 8. We have notified both the State Police (Greenville Satellite Barracks) and Greene County Sheriff Department (Lt. Overbaugh) and both will be present to help with the portion of the race that crosses SR 32. Town Supervisor Paul Macko has been notified of the event. Written permission from the town will be provided prior to 2 weeks before the event.
- 9. Event day communication among volunteers and safety personnel will be by cell phone.
- 10. Emergency services will be provided by the Greenville Volunteer Fire Company who will have a first aid SUV present and EMS on call.
- 11. No spectator control on roadsides will be necessary as finish line and start line will be within the town park
- 12. No pavement markings will be necessary
- 13. Event day signage will consist of 18X24" yard signs on stakes at each intersection, as shown on attached map. Text will consist of the Rotary logo and sponsor's name. No CMS will be used.
- 14. A support vehicle using flashers and driven by a Rotary volunteer will follow the final runners/walkers.



Sponsors will receive recognition in the form of a program in the goodie bag and a yard sign on stakes which will be placed along the route, as well as signage at the start/finish. There will probably be different levels of sponsorship available. We estimate each sponsor will contribute \$100 or more. Yard sign costs will be around \$15+. This needs a little more research/planning.

Costs are \$900 for Greenleaf Racing. They will provide timing and race day support as well as the registration services. They've already been a big help with advice! Insurance is estimated at around \$300. This is in addition to the liability insurance provided to our club by our RI dues. Due to the nature of the event, the committee thinks this is an important safeguard.

Safety and traffic control. The town of Greenville does not require permits We've been talking to Paul Macko and he is on board with the event. Traffic control will be provided by the Greene County Sheriff Department and the State Police. This has been arranged. The Greenville Volunteer Fire Co. will provide first aid in the form of an SUV on site and EMS on call. Fire Company members are also available for traffic support (if there's no fire!!!). We have applied to the New York State department of Transportation for a permit, as the race route crosses State Route 32.

Volunteers needed: We would like Rotary volunteers at each intersection along the route. We will also need volunteers for race day registration and crowd control and parking at the town park. We estimate 25+ volunteers needed, but this will depend on the number of participants.

Under the new law, money must be spent one of four ways: Responding to the pandemic and its negative economic impacts; helping essential workers; restoring lost revenue; or making investments in water, sewer and bipadband infrastructure. The lunds cannot pay for pensions of be-used to cut taxes.

Fifty percent of the moneymust arrive by mid-May, and the other 50% must arrive within a year after that: Governments: will have until the end of 2024 to



"We don't have any final decisions on how the money for the county will be used, but it will be used; acquaing to whatever the guidelines the U.S. Treasury puts out," Greene County Legislature Chairman Patrick Linger, R-New Baltmore, said Tuesday,

While the four categories broadly-indicate how the funds can be allocated, the county is waiting for more specific guidance, he said.

"That is the framework that was passed within the legislation, so now the U.S. Treasury

has to come up with the guidelines saying here's what can and can't happen," Linger said.

The money must be spent before Dec. 31, 2024, and that may pose a conflict for one of the uses the county has been considering — expansion of broadband, Linger said.

"Some of the information we had early on before [the bill] was passed was a little bit different from the final legislation," Linger said. "On some of the things we were thinking about setting the money aside for, like the broadband effort, if it can't be spent by the end of 2024, that wouldn't be a good use of that

money because we would just lose it."

While using the stimulus funds to build the needed broadband infrastructure may not be possible due to time restrictions, the county has a mapping project in progress that could use the money, Linger said.

"We are still probably going to use some of the funds for broadband because we are already actually in the middle of a study to find out what roads, tight down to what houses, have availability of broadband and who doesn't, so we are looking at about a \$100,000 study to determine that and from there, we would have to engineer a plan to build it out, figure out how much it will be and then how to pay for it, but then there is the buildout

itself," Linger said.

Construction of the needed infrastructure would probably take longer than the end of 2024, Linger added.

The town of Catskill is slated to receive the largest chunk of the stimulus funding countywide at \$1,243,262.

The town board has not yet discussed how the money will be spent and no money has been received yet, Town Supervisor Dale Finch said Tuesday.

"Catskill has not decided how that money will be utilized," Finch said. "I think as a town board we will prioritize projects within the town and see how much those projects would cost the town, and then moving forward make a decision as a town on how that money would be spent. We have time to decide

what viable projects we want to work on and that would be a town board decision."

The federal funds will be a great help to municipalities, Finch said.

"I'm thankful and delighted

"I'm thankful spid delighted that money is coming from the federal government directly to the villages and towns "this is the first time! am seeing money coming directly, in a stimulus package, to help out local towns, especially going through the pandemic, which has been quite aburden on the local community," Finch said.

The town of Coxsackie was allocated \$912,757 and of that, roughly \$290,000 will be given to the village based on population, Town Supervisor Rick Hanse said.

The town has not received

any funds at this time, he said.

The town council has not discussed the use of the relief funds, but Hanse hopes to see infrastructure projects on the list.

"It looks like the guidelines will be pretty loose and we have things to spend it on," Hanse said. "We could use another ambulance—those are north of \$180,000, so they are expensive. We have some roads out in Earlton—longroads that are expensive to pave that need regrading and repaving, so we are looking into that."

The town of Hunter is expected to receive \$288,383, according to the National League of Cities. No funds have been received there and town officials have not decided how the money will be used, Hunter

Town Supervisor Daryl Le saidTuesday. "We have a meeting comi

up next Tuesday and I wou saywe will discuss it then," Le said.

Other towns in Gree County will receive funding follows: Ashland, \$81,721; Al ens, \$432,300; Cairo \$703,6 Durham, \$291,235; Greenvil \$390,727; Halcott, \$27,3: Jewett, \$103,331; Lexin ton, \$84,793; New Baltimo \$356,941; Prattsville, \$76,1: and Windham, \$183,626, according to the National Leag of Cities.






COVID #9: Transportation, Freehold, Web

Happy Spring!

A mostly dry and mostly warm (at times, balmy) spring season has helped give most of us an extra spring in our step, especially after a grinding February. And getting outside has lifted many of our spirits.

Freehold Days Ken Mabey

Memories are important to many of us as we grow older. They are a way to revisit our childhood places and people we have known, both friends and family. I lived in Freehold for most of my years up to the early teens. It is one of the places that have always seemed most like home to me.

We were living at my Grandfather Alvah Sutton's house so my Mom, Edna, could cook and help with the house while her mother, Jessie, was very ill, and died in 1938. My Dad could tend the garage if Grandpa had to go to Albany for supplies, and also helped on his relative's farms. We continued to live there until 1941 when I was four years old, and 1940 and 1941 is where my memory begins. Our neighbors were the Lacy family, and Dr. Curtis Lacy was our family physician. Mary Ellen Lacy was about my age and we often played together. Unlike today, house calls were common practice, and I have since learned Doctors were paid a little amount compared to

today, and sometimes received in kind (foods, vegetables from the garden, a cake, bread, or pie, a chicken, or eggs) if money was short. Wood's store was across the street, and also the Antus family, north of the store, and directly across from us. Leon and Howard Wood ran the store, and Ray Bennett worked for them.

The house and my grandfather's garage were the places most familiar to me. I recall people making deliveries to the house. It was a gathering place in the kitchen some mornings. Pete Keefe brought milk, "Fat" Howard brought eggs (never could understand his nickname, he wasn't fat, stocky perhaps!) Sometimes Bill Brank, who drove truck for the town, and some helpers would stop for a coffee break. The garage was where several town men would come to play dominoes. There was a card table set up in Grandpa's office with a display case of candy, and other goods for sale. Elmer Simmons, Herb Antus and Charlie Poole were some that I recall, but know that there must have been others. Grandpa was most always working, but didn't mind having friends there who were always willing to help out if needed. There was a tire rack in the office that I loved to climb through usually leaving black marks on my clothes and person much to my Mom's dismay. Sometimes Ken Ingalls would stop by and shout "where is that dirty urchin?" That always made me laugh. The garage was a busy place where people stopped for gas, an oil change or repairs. Some were Pete Raffo, Elmer Story, Harman Becker, Edgar Palmer, Lester Story, Clint Story, Lloyd Simpkins and others I don't recall being only three and four years old at the time.

Of course the real focus of this story is my grandfather. To those of you familiar with Don's calendars and photos there are several: The Sutton garage, Alvah Sutton's band, Free-

hold men's hunting group, the blacksmith shop with Gramp and Lonnie Hale. Grandfather started his working life as a blacksmith, and as cars came along, his shop became a garage. He and Mr. Antus built a crystal radio in the early days, my mother had told me. Musically, he and his band members played for dances at Haight's Hall. He played saxophone,

clarinet, fiddle, and chords on the piano. I still have boxes of his sheet music. He taught me to sing songs, "Turkey in the Straw," "Darling Nellie Gray" and "Old Dan Tucker". On Thanksgiving Day, 1940 we went to my Mabey grandparent's farm in Cornwallville and after dinner my two grandfather's played music together, with fiddle and piano. So much a part of life in that era was family entertainment.

Grandpa Sutton was a strong supporter of FDR, and I recall going to Jennie Parks where the polling place was in 1940, with my parents and grandfather when they voted. Aunt Jennie always served oyster stew on Election Day. It was an occasion and helped to get people out to vote. One of the men asked me, "Well Kenny, who are you going to vote for?" I said, "Wendell Wilkie." Not a good answer for a child whose Grandfather was a Democrat. Guess I was somehow fascinated by the name, and a good reason why children don't vote. It did make everyone laugh. Later my mother made sure I knew who FDR was.

Sadly for our family, Grandfather Sutton died in 1942, but for those who knew him he is always in our memory. The Irish poet and writer, John O'Donoghue wrote, "there is a place where our vanished days secretly gather. Memory as a kingdom, is full of the ruins of presence. It is fascinating that in your memory, nothing is ever lost or ever finally forgotten."

From the early start-up and establishment days of the "Boarding House" era in the Greenville area in the 1920s, there was an evolution of transportation modes in association with it. The introduction of private summer / second home residences also had an impact.

Since automobiles were still a rare personal commodity then, especially for distance travel, public transportation was depended upon by downstate urban dwellers to come north to Greene County. Initially, the Hudson River Day Line Ship System played a major role. From NYC to Albany, with multiple scheduled dockings along the way, several steamships carried multitudes of passengers. The Catskill Landing was the Greene County connection where House owners would arrange arrival pickup and return departure service for their guests. More and more "farms" began to realize and seize the opportunity to augment their agricultural income, or even replace the farming aspect, with the housing of summer guests. A new fledgling industry was born.


My Grandparents, Karl and Anna Flach were one of the pioneering couples to offer bedrooms and meals, along with a rocking chair on the front porch, at their Maplehurst Farm, east of Greenville in Hannacroix. All eight of their children were displaced from their rooms in the large farmhouse to an outbuilding/shed for the entire summer to accommodate paying guests. The fee for a one week stay—transportation, a room, three major meals a day, with the rocking chair and all the fresh farm air you could breathe—\$3 (yes, three dollars) in 1925.

The new rural industry progressed well until the terrible back-to-back combination of the Depression years of the 1930s and WWII through the mid-forties. The post-war years then presented a renewed opportunity for growth and escalation of the vacation/travel industry for those still interested in

pursuing it. (My Grandparents chose not to, instead returning to traditional farming and their bakery business). Ultimately, for those willing to invest and modernize, a more "resort" atmosphere was created. Accommodation refinement, grounds beautification, and activity planning followed.

The increased comfort and dependability design of rail systems and trains, highway construction/improvements, and buses and automobiles brought about a decline in the River Ship travel. By the 1950s & 1960s, for the most part, resort guests (or "Boarders" as "we locals" referred to them), as well as the summer-home residents, drove their own vehicles to the area for their "stay." Many, however, particularly urban dwellers who did not own or drive cars, needed alternative transportation to travel here and then get around to visit our fine sites and businesses.

A more modern and convenient "travel in/out" option was introduced: Bus service. I believe I recall correctly that it was Mountain View Coach Lines that began serving Greene County, originating in NYC Port Authority and traveling north via Rt. 9W and 32 (and eventually parts of the NYS Thruway upon its construction), making multiple stops

along the way, with Greenville the farthest north destination for that itinerary. At least one bus a day would arrive here midday, lay over for an hour or so and then make the scheduled return trip.

Personal side-story: From my 2 North Street (Rt. 32) Barber Shop location, I had a panoramic view of the Rt.81/32 Main town intersection. The bus would roll into town with passengers disembarking at the intersection. The drivers would then park on the Firehouse Lane between the creek next to me and the Mobil Station to await their return time. One would think "all good - no problem," except for this snag. For comfort reasons, they would leave those nasty diesel engines rev at a high-speed idle for the entire time—for heat on the cool days and AC cranking on those sweltering, humid August days. The exhaust fumes and smoke belching from those racing beasts would blanket the village proper. Good -bye clear, fresh Catskill mountain air, peace and quiet. Many of us in the "pollution-path" made a request of our town officials to contact EnCon and the bus company to demand a "fumigation cease." Although taking some time (months), eventually common sense and courtesy did prevail and buses were shut down during layover.

Another travel option unfolds: Some guests and visitors would travel up via train to the Hudson Rail Station. They would then need a way to their destination here and then to get around locally during their stay. Greenville resident and entrepreneur "Crow" Griffin met that need with "Crow's Taxi Service". I recall his "land-yacht" sized Oldsmobiles carrying "city folks" to and fro regularly.

Side-story #2: Crow's Taxi Service became so busy that he added a second car and employed an additional driver to cover the demand. Knowing the particulars of the situation as I do, I cherish this memory of the occurrence to this day. As you may imagine, a non-driving urban dweller would not be accustomed to our twisting, winding, hilly, country-road terrain. So, one afternoon when a Gentleman staying at Sunny Hill (no hills, turns, or bumps to get there) was dropped off at my Shop by Crow's assistant driver (locally

known to be a bit of a speedster at the wheel), he entered visibly shaken and pale as a ghost. I inquired if he was ok. He appreciatively replied he thought so, then proceeded to ask if there might be another mode of travel he could use to get back to the Resort. He was very cordial but relayed that he didn't care to experience another adventure quite like the ride just taken. All I could offer was that he call the resort, explain his plight, and I was sure that they would accommodate him. Still have to smile when I recall that one!

Those were the days; when the Village proper was all hustle-bustle from Memorial Day to Labor Day. It was said that our area population more than doubled May - September in the 1950s, 1960s, and 1970s. I must add of course, that the Generational Resorts still operating and flourishing here today obviously far exceed the size, guest volume, quality accommodations, and activity offerings of the times addressed here. That has been accomplished through family dedication, hard work, skillful management, massive financial investment, modernization, and major adjustments to the vacation environment encountered over the decades.

Hudson Transit Lines (Shortline Bus Co) of Mahwah, N.J. had a daily run from N.Y. C. Port Authority Bus Terminal to Greenville. It ran every day leaving P.A. about 8:30 am arriving at Main St. about Noon and then going up to Shepard's to lay over until 3:00 for the return trip. The regular driver was a Mr. Yost. We did his run for him when we were in training while he cushioned, (sat on the seat opposite the driver). The layover was by the ball field. There was a sign on the south side of the large corner hall building, dining hall/dance hall.

From ships, to trains, to buses and cars, to property booms and busts, to business entrepreneurs, and the many significant

transformational changes, the Greenville area has undergone an interesting last 100 years.

Finally, every issue, all 293, of the Greenville Local History Group Newsletters are online.

I had longed to give easy access to past issues of the Newsletter to our local history community. As the years had rolled on, distant newsletter issues become even more distant memories of productive meetings that had meant so much to me. Hopes of breathing new life into past issues was simply that — a hope.

Coincidentally, Vedder Library Archivist Jonathan Palmer (also Greene County Historian) had written for Porcupinesoup.com the following two paragraphs of a column about an idea I recognized only too well:

"Much like the horse, historians leave droppings. Ours are allegedly more useful than our equine counterparts, but the horse is quite fortunate that on most mornings someone comes by to shovel the stables out. Once a stall is mucked those droppings get put to good use as manure in fields and gardens — fertilizing a season's harvest with what a horse makes naturally from last year's hay.

"Optimistically I conjecture that "historian droppings" fertilize the minds of those who deign to read what we write. For better or worse the stuff we churn out invariably rings a bell with someone or gets someone curious enough to study further of their own accord. The problem is that, once our articles are deposited, nobody comes by in the morning to clean up the aftermath. My writing this article is all well and good, but once it is read and done with, it lands on a stratified pile of

"history stuff" which really hasn't been cleaned or straightened up since 1927."

For my part, I had/have a website that posted GLHG newsletters of 2012-2016. Then, a hosting service fell by the wayside, my web making program was not readable on a Windows 10 update, and I was left in a dither. Almost five years have gone by before I recently secured the services I needed to restart my website and perhaps to effect some of that mucking Jonathan referred to.

First, a key ingredient came along. I bought a new printer, one that when fed a stack of papers could produce a pdf file. What if... what if... I could do that with a newsletter. I tried it. Voila!

Of course, I had to stop and read along the way, and there were times I could still picture the evening and/or the conversation. Some of the write-ups were rediscovering topics that I vaguely remembered covering and wishing I could find them again. The one bittersweet part of all this was the memories of people who have crossed my path over thirty years who are no longer here. I started

to list them but, even more bittersweet, I quit when the list was getting longer than I could stand.
